Entry Level Coiled Tubing Operator - JOB DESCRIPTION

PRIMARY ROLE:

Provide ongoing support to assist operations in Operating equipment to increase oil & Gas flow from new or producing wells or to remove stuck pipe, casing, tools, or other obstructions from drilling wells.

KEY FUNCTIONS: Operations (Daily work assignments as needed and assigned by Supervisor):

- Training to develop knowledge and skills to maintain all equipment related to coiled tubing, and support equipment.
- Operate auxiliary equipment and pump unit while maintaining excellent quality control and in accordance with company policies and procedures.
- Develop a working knowledge of the major components of coiled tubing & pumping equipment.
- Drive specialized company equipment to and from service jobs, following accepted company convoy procedures.
- Spot equipment into position; rig up treating lines, hoses, wellhead connections, etc., to trucks, tanks and wells, according to company location safety standards.
- Operate assigned equipment during treatment, recognizes equipment malfunctions, and correct them as necessary or report them to Service Supervisor.
- Strive for superior service quality

SKILLS:

Communications:

Verbal: Employee must be able to listen, understand, ask questions, and follow supervisor directions/instructions.

Read: Employee must have the ability to read and comprehend occasional detailed written orders for non-routine or special assignments, operating manuals, and other written communications.
